4. Minutes of October 6, 2025 Park Advisory Board Meeting

5. Minutes of November 5, 2025 Park Advisory Board Special Meeting

6. GO Bond Updates

Parks Director Josh Quigley provided a PowerPoint presentation of the General Obligation Bond projects, comparing their progression from when he joined the city in February 2024 to February 2025 to current day. Bid opening for the Sand Springs Dog Park – Phase 1 is at 10:00 a.m. on Thursday, February 12th.

7. Special Events Updates

Case Community Center hosted Falloween on October 17th and Winter Blitz on January 2nd. Runners will return to the Keystone Ancient Forest for Ancient Trail Trek on February 21st. The Thunder Court in Case Community Park has been repainted and will be rededicated on March 21st. On April 18th Activate Oklahoma will hold a bike ride with Herbal Affair as its destination. The Veterans Chilln & Grilln Car Show will be held on October 9th and 10th at the baseball parking lot in Case Community Park.

8. Golf Course Updates

Brian Talley announced that rounds were up for November and December, adding a 10% increase in revenue. A water line break occurred overnight Saturday into Sunday causing erosion issues to cart paths and fairways (no greens) that are being corrected before reopening the course on Wednesday February 4th. Brian noted sixty events are booked between May and September 2026 alone. There has been no backlash to the new golf fee structure introduced on January 2nd.

9. Recreation Updates

Recreation Manager Joy McAfee shared the Case Community Center will be 18 years old in September. She shared Park staff celebrating their work anniversaries are Linda Pinkerton with 11 years, Gene Hartman with eight years and Melissa Cartwright with five years. We are four months into RecDesk and are closer to offering classes with fees. Both full-time Case Center Coordinators Linda Pinkerton and Kaia Forbes received a title change and are now Enrichment Program Coordinators. The seniors have requested a pool table through the CENA Grant three separate times, being declined each time. As a result, parks staff renewed the Senior Association agreement and are co-purchasing a pool table from One Billiard. Full time KAF Coordinator Rocky Kelley has shared humorous Facebook posts about the upcoming Ancient Trail Trek which have garnered over 25k views.

10. Park Project Updates

Park Project Manager Tyrel Rogers highlighted project updates. The Geotech Report confirmed Page Park is sitting on sand, nothing more. Interior work has begun at the museum, aiming for completion by Herbal Affair. The contractor will start in the West Gallery, move to the East Gallery then the center section. When preparing for the interior work, the upstairs curtains fell apart when taken down. Fortunately, the new UV film on the museum windows make curtains optional. Park Maintenance will perform demolition at the dog park to save money.

A prescribed burn is planned at the Keystone Ancient Forest, weather permitting. The Veteran's Center has received kitchen and exterior lock updates and is scheduled for pest control services beginning next week. Sand Springs Lake had vegetation cleared near the gazebo for better fishing access. Park Maintenance acquired a "new" used gator with a cab for trail work.

Parks Foreman Richard Coe reported the new maintenance building is complete and the crew now has direct access to Case Community Park on the south side of the yard. Baseball has a landing area for dirt / conditioner.

Josh Quigley shared that artist Thomas Dambo will be visiting the Tulsa metro area to consider KAF as a site for his Troll artwork. If chosen, Oklahoma will be the fifth state to have these unique pieces of art. Legal is currently working on addenda to the BMX, soccer, baseball, and softball group agreements that will address costs for the portable restrooms and dirt work. Josh disclosed Kason Hughes, former part time Case Center Coordinator, is now the full-time Sports Coordinator. He will be the primary point of contact with the sports user groups even though Park staff are still available. Kason will maintain the master calendar for the user groups as well as work on new public sports opportunities like an adult basketball league, an outdoor volleyball or pickleball league, for example.

City Manager Mike Carter stated Torchy Wolfe wants to sell the land between her residence, including a building ideal for storage, and the north side of the dog park for \$45k. The new Animal Welfare shelter continues under construction.

beyond the normal responsibilities of a citizen or public servant. These actions reflect true heroism and an unwavering commitment to the well-being of others.


Parks & Recreation Related Service (10 points)

He will be bury at Arlington National Cemetery with full military honors in March in 2025.



Col. (Ret.) Bill Gene Lockwood

Colonel Bill Gene Lockwood (United States Army, Retired), age 92, passed away August 25, 2025, in Medical Center Enterprise following a short illness. Funeral arrangements are being made by Sorrells Funeral Home of Enterprise, Alabama, for burial with full military honors at Arlington National Cemetery, Arlington, Virginia, at a future date.

Colonel Lockwood was born August 1, 1933, in Osage County, Oklahoma. After graduating from public schools in Sand Springs, Oklahoma, he was drafted into the US Army as a 19 year old Private. He eventually served over 31 years of continuous active military service, retiring as a full Colonel. He received his Commission via the Infantry Officer Candidate School at Fort Benning, Georgia, in 1954. During his service years he earned his Bachelor's Degree from the University of Omaha, Nebraska, and a Master of Science Degree from the University of Illinois. He was also a graduate of the United States Command and General Staff College, and the United States Army War College.

Major assignments for Colonel Lockwood included Rifle Company Commander in Korea; Battalion Adjutant with the 11th Air Assault Division; Assistant Division Aviation Officer with the 145th Aviation Battalion in Vietnam; Helicopter Gunnery Instructor Pilot; Branch Chief at Fort Rucker, Alabama; S3 of the 101st Airborne Division's Aviation Group in Vietnam; Operations Officer in the National Military Command Center for the Organizations of the Joint Chief's of Staff in the Pentagon; and Military Representative to the US State Department in Washington, D.C. At the United States Army Aviation School at Fort Rucker, Alabama, he served as Director of the Department of Graduate Flight Training; served as Executive Officer for the United States Army Aviation School; and as Commander, First Battalion, United States Army Aviation School Brigade. In Germany he was Chief, G-3 Air Section of NATO's Central Army Group. He then commanded a United States Support Activity in the Netherlands for three years after which followed a three year assignment as Commander of the Heilbronn Military Community in Germany. His last military assignment was as Secretary for the United States Army Aviation School at

Fort Rucker, Alabama.

Col. Lockwood's Awards and Decorations include two awards of the Legion of Merit, three awards of the Distinguished Flying Cross, two awards of the Bronze Star, the Meritorious Service Medal, 13 awards of the Air Medal, three awards of the Army Commendation Medal, the Vietnamese Cross of Gallantry w/gold star, the Master Army Aviator Badge, Army Parachutist Badge, Air Assault Badge, Pathfinder Badge, Army Ranger Tab, and Organization of the Joint Chiefs of Staff Badge. He was rated as a Master Aviator for both fixed and rotary wing aircraft.

After retirement from the military, Col. Lockwood worked for himself and became a very successful investor in the real estate and equities markets, which he continued until his passing.

Col. Lockwood was preceded in death by his wife of over 47 years, the former Anna Marie Merkl of Vilseck, Germany, as well as his brother, Don, and sister, Geraldine, both of Oklahoma, but is survived by numerous beloved nephews, nieces, cousins and a lifetime of friends.
